## Scope

## **Responsibili** es

Management:

- Management is responsible for establishing a culture of zero tolerance towards modern slavery and human trafficking within the organiza for.
- They must ensure that appropriate policies, procedures, and training programs are in place to iden fy, prevent, and address instances of modern slavery.
- Management should provide leadership and resources to support the implementation of this policy and promote transparency and accountability throughout the organization.

Procurement and Supply Chain:

- The procurement and supply chain teams are responsible for conduc@ng due diligence on suppliers and business partners to assess their compliance with an -slavery and human trafficking laws and standards.
- They must incorporate contractual provisions and supplier codes of conduct that prohibit modern slavery and require suppliers to uphold ethical labour prace.
- The procurement and supply chain teams should work collabora vely with suppliers to address any instances of modern slavery iden fied within the supply chain and support remedia on efforts.

Employees:

- All employees are responsible for familiarising themselves with this policy and understanding their role in preven role in grown modern slavery within the organiza role on and its supply chains. They must report any concerns or suspicions of modern slavery to management or the designated compliance officer promptly.
- Employees should par cipate in training and awareness programs to recognize the signs of modern slavery and understand their responsibilities in upholding ethical labour practices.

## **Policy Principles**

*Zero Tolerance*:Leroy Solutions LTD] has a zero-tolerance policy towards modern slavery and human trafficking in all its forms. We will not knowingly engage in or support any active sthat involve modern slavery, forced labour, or human trafficking.

*Transparency and Accountability:* We will maintain transparency in our operations and supply chains regarding efforts to prevent modern slavery. We will hold ourselves and our suppliers accountable for upholding ethical labour practices and complying with relevant laws and standards.

*Continuous Improvement:* We are committed to con nuously improving our policies, procedures, and praceces to prevent modern slavery. We will regularly review and update this policy to ensure its effectiveness and alignment with Australian legislative requirements and international best praceces.

### Reporting and Compliance

Any instances of modern slavery or human trafficking iden fied within Leroy Solutions LTD, or its supply chains must be reported immediately to management or the designated compliance officer. Reports will be investigated promptly, and appropriate remedial action will be taken in accordance with applicable laws and regulations.

#### **Training and Awareness**

Leroy Solutions LTD will provide training and awareness programs to employees, contractors, and suppliers to educate them about modern slavery, its signs and indicators, and their responsibilites in preventing it. Training will be conducted regularly to ensure that all relevant stakeholders are equipped with the knowledge and tools to address modern slavery effectively.
